On Thursday, February 27, 2014, at approximately 5:14 p.m., members of the Seventh District received a call for the report of a "Man Down" in the 4300 block of Halley Terrace, Southeast, Washington, D.C. Once on the scene, Seventh District members located Mr. Jonathon Adams, suffering from a stab wound to the neck. Mr. Adams was transported, via an ambulance from the District of Columbia Fire Department, to the MedStar Unit of the Washington Hospital Center where he was pronounced dead by Dr. Aboussaly at 5:47 p.m.

During the initial on scene investigation, technicians of the Metropolitan Police Department Forensic Science Division located the crime scene in the main level hallway of 43██ Halley Terrace, Southeast. The building consists of four (4) units: two (2) on the main level and two (2) on the second level. The crime scene is located in-between units █████ located on the █████ level. Technicians observed a blood trail which leads out the apartment building and extends to the odd side of the street. The decedent collapsed in front of 43██ Halley Terrace SE.

As a result of the MPD investigation, it was learned that the decedent had been in possession of an Android smart phone. A family member (hereinafter referred as W-1) advised that the decedent should have been in possession of this phone. No cellular telephone was recovered from the decedent.

During the course of the investigation into this homicide, additional witnesses were located and formally interviewed by your affiant and other Detectives of the Criminal Investigation Division, Homicide Branch. One such witness, hereinafter referred to as W2, reported that IT was inside of 43██ Halley Terrace, Apartment 2, Southeast, when IT heard a knock at the door. W2 reported that IT woke IT's nephew, which IT identified as Jibril Abdul-Muwwakil (hereinafter referred as the defendant), who was asleep on the bed in the living room. The defendant opened the door and went into the hallway. W2 reported that several minutes later IT heard hard knocking on the door and when IT opened the door, the defendant was standing in the hallway with blood on his hands, holding an Android cell phone. According to W2, the cell phone that the defendant was holding did not belong to the defendant. W2 reported that IT asked the defendant what happened, but the defendant did not say anything. W2 said that the defendant went into the bathroom inside of Apartment 2. W2 reported that after a few minutes, the defendant came out of the bathroom and left the apartment.




