During my tenure as Acting Vice Chancellor of Educational Services and Institutional Effectiveness at State Center Community College District, I Co-Chaired the High-Speed Rail Educational Planning Task Force with the Dean of the College of Engineering at California State University, Fresno. The group was charged with coordinating the resources and ambitions of a disparate group of unions, CSU's, community colleges, and state and local agencies in order to develop a "plan to plan" for the training of workers capable of working at all levels during the installation of the high speed rail system.

Although we were successful in developing a document of merit, it was not funded, but it still serves as an outstanding example of diplomacy, cooperation, and innovation for the planning of intersegmental initiatives in the future.
