SUBJECT: YOUR FREEDOM OF INFORMATION ACT (FOIA) REQUEST, FILE NUMBER USMC-HQ 2013F010192

This is in response to your January 22, 2013, FOIA request seeking a copy of the backing track used during Beyoncé's Inauguration performance, as well as copies of other backing tracks created in preparation for Inauguration events, whether or not they were actually used. Your request was controlled under file number **USMC-HQ 2013F010192**.

We initiated a search of the files maintained by the Marine Band, which identified 36 music tracks as responsive to your request. Upon review, we have determined that the tracks are releasable. At the enclosures, please find two CD's and the list of the songs contained on those CD's.

Please be advised that the recorded <u>sound</u> of the Marine Band is in the public domain and as such is provided per the FOIA request. However, even though the Marine Band's sound is in the public domain, the musical selections still may have copyright encumbrances attached to them. It is entirely the requestor's responsibility to give all necessary notices, acquire all copyright clearances, and pay all required fees as necessary for any use of copyrighted music. Every music title should be researched. We cannot relieve anyone of their responsibility to obtain licenses or permission from the various copyright holders and/or music publishers involved. Neither the Marine Corps nor the Marine Band accepts any responsibility for any use of Marine Band sound other than our own distribution.

In addition, please note that Ms. Beyoncé Knowles-Carter's vocals/music do not belong to the Marine Corps. Therefore, you will have to send your request directly to Ms. Knowles-Carter's attorney, Mr. Jordan W. Siev, Esq., ReedSmith LLP, 599 Lexington Avenue, New York, New York 10022. We have categorized you as an "other requester" for the purpose of assessing FOIA processing fees. As such, you are entitled to two hours of search time and 100 pages of duplication free of charge but are responsible for the payment of any fees beyond that. In this instance, the applicable fees did not exceed your free entitlement so there is no charge for processing this request.
