1 Plaintiffs allege, upon knowledge as to their own acts and upon information and belief as
2 to the acts of others, as follows:

3
4 **NATURE OF THE ACTION**

5 1. For over 40 years, sound recordings have been protected by California common
6 law, and for over 30 years they have been provided statutory protection under Section 980 of the
7 California Civil Code. As a result of 1972 amendments to the United States Copyright Act, sound
8 recordings "fixed," *i.e.*, created before February 15, 1972 ("Pre-72 Recordings"), continue to this
9 day to remain exclusively subject to protection under California state law, whereas sound
10 recordings "fixed" after that date are subject to exclusive federal copyright protection. In this
11 action, Plaintiffs seek to vindicate their valuable rights in their Pre-72 Recordings and prevent the
12 continued violation of those rights and the appropriation of Plaintiffs' Pre-72 Recordings by
13 Defendant SiriusXM Radio Inc. ("SiriusXM").

14 2. The conduct of SiriusXM presents the paradigmatic example of a commercial
15 business that is based on, uses, and profits from the intellectual property created by and owned by
16 others, without obtaining the right to do so, and without paying for it. SiriusXM refuses to obtain
17 licenses and pay for the daily public performance and reproduction of thousands of Plaintiffs' Pre-
18 72 Recordings that SiriusXM copies and transmits to millions of its paying subscribers over
19 dozens of its satellite radio channels. SiriusXM refuses to obtain those rights and to compensate
20 Plaintiffs for the use of their property even though (a) it profits handsomely (in the tens of millions
21 of dollars) from its performance of these classic recordings; (b) it promotes its service by touting
22 the availability of such recordings; and (c) it recognizes that it must license and pay for the
23 performance of *post*-1972 sound recordings over its service.

24
25 **ALLEGATIONS COMMON TO ALL CAUSES OF ACTION**

26 **The Parties**

27 3. Plaintiff Capitol Records, LLC is a Delaware limited liability corporation, with its
28 principal place of business in the State of California.

1 4. Plaintiff Sony Music Entertainment is a partnership duly organized and existing
2 under the laws of the State of Delaware, with its principal place of business in the State of New
3 York.

4 5. Plaintiff UMG Recordings, Inc., is a corporation duly organized and existing under
5 the laws of the State of Delaware, with its principal place of business in the State of California.

6 6. Plaintiff Warner Music Group Corp. is a corporation duly organized and existing
7 under the laws of the State of Delaware, with its principal place of business in the State of New
8 York.

9 7. Plaintiff ABKCO Music & Records, Inc. is a New York corporation with its
10 principal place of business in the State of New York.

11 8. Plaintiffs are informed and believe, and on that basis allege, that Defendant
12 SiriusXM is a corporation duly organized and existing under the laws of the State of Delaware,
13 with its principal place of business in the State of New York.

14 9. The true names and capacities, whether individual, corporate, associate, or
15 otherwise, of all Defendants sued herein as Does 1 through 10, are unknown to Plaintiffs, who
16 therefore sue said Defendants by such fictitious names. Plaintiffs will seek leave of the Court to
17 amend this complaint to state their true names and capacities when the same have been
18 ascertained. Said Defendants are liable to Plaintiffs because they either directly performed all or
19 some of the acts alleged hereinafter or were acting as the agent, principal, alter ego, employee,
20 representative, or otherwise participated in the acts alleged.

21 **Plaintiffs and Their Business**

22 10. Plaintiffs are record companies in the business of producing, manufacturing,
23 distributing, selling, and otherwise exploiting sound recordings. Collectively, Plaintiffs own the
24 majority of commercially exploited recorded music in the United States, and are the successors-in-
25 interest or the owners of many classic and famous record labels such as Mercury, RCA Victor,
26 Reprise, Columbia, Blue Note, Motown, Decca, Elektra and Sire. Sound recordings that Plaintiffs
27 own or in which they possess exclusive ownership interests include both copyrighted sound
28 recordings (those "fixed" after February 15, 1972) and Pre-72 Recordings (those "fixed" before

1 February 15, 1972). Plaintiffs' catalog of Pre-72 Recordings includes some of the most famous,
2 popular, and valuable sound recordings in the world, spanning virtually every genre and most
3 major recording artists who recorded during the years preceding 1972. Among these works are
4 sound recordings containing iconic performances by the Beatles, the Beach Boys, the Rolling
5 Stones, Bob Dylan, Jimi Hendrix, the Eagles, Led Zeppelin, the Temptations, the Supremes,
6 Stevie Wonder, Buddy Holly, Chuck Berry, Marvin Gaye, Nat King Cole, Otis Redding, Aretha
7 Franklin, Simon & Garfunkel, Patsy Cline, and Louis Armstrong. A representative list of
8 Plaintiffs' Pre-72 Recordings is attached hereto as Schedule A and incorporated herein by
9 reference. All of these recordings are among the iconic recordings of the "Rock Era," and many
10 of them have been ranked by Rolling Stone Magazine in its list of Top 500 Rock Songs of All
11 Time. (Where applicable, the Rolling Stone Magazine ranking of a representative recording on
12 Schedule A is denoted as "(#)".)

13 11. Plaintiffs' recordings, including the Pre-72 Recordings, are the product of an
14 enormous investment of time, effort, money, and creative talent in discovering and developing the
15 recording artists and creating, manufacturing, advertising, promoting, selling, and licensing their
16 sound recordings. To this day, the Pre-72 Recordings remain highly valuable and popular,
17 attracting both old and new fans. Plaintiffs continue to invest substantial money, time and effort
18 in their Pre-72 Recordings, for example, by re-mastering or improving the quality of the Pre-72
19 Recordings, promoting and advertising the recordings, re-releasing them as "deluxe editions," box
20 sets, "Greatest Hits" or compilation albums, and arranging to license them for use in commercials,
21 movies, and streaming services on the Internet. Plaintiffs' investments in their Pre-72 Recordings
22 have been and are incentivized by their expectation that their investments will be rewarded by the
23 revenues, royalties, and other compensation received from their ongoing exploitation of these
24 works.

25 12. Plaintiffs exploit their Pre-72 Recordings in a number of ways, including by
26 offering for sale compact discs and digital music files for download, by licensing them to digital
27 services (including for digital streaming to the public), and licensing them for use in audiovisual
28 works such as motion pictures, television programs, and music videos. Plaintiffs receive

1 payments for, among other uses, the reproduction and digital public performance of their Pre-72
2 Recordings. The payments that Plaintiffs receive are used to recoup Plaintiffs' ongoing
3 investment and expenses, and to compensate the recording artists, producers, and others, for their
4 talent and work in creating the Pre-72 Recordings. The performances of many recording artists
5 are embodied solely in Pre-72 Recordings, and they and/or their families rely heavily on the
6 money they receive in return for the performance and other exploitation of those recordings.

7 13. Digital music streaming is becoming an integral part of Plaintiffs' business. As
8 music consumption habits have changed, and greater numbers of people listen to music via digital
9 radio channels in lieu of purchasing music on CDs or digital music files, record companies and
10 their recording artists rely increasingly on revenues from the digital public performance of music,
11 including Pre-72 Recordings. Thus, it is extremely important to Plaintiffs' business that they are
12 fairly compensated for such public performances, and that those who profit from the performance
13 of digital music obtain authorization and pay the record companies and recording artists for their
14 use of Pre-72 Recordings.

15 SiriusXM And Its Unlawful Conduct

16 14. Defendant SiriusXM is the sole provider of satellite radio service in the United
17 States. SiriusXM uses satellite technology to transmit its channels to its subscribed listeners.
18 SiriusXM's channels are beamed from the ground up to satellites, which then transmit digital
19 audio files to radio receivers possessed by its subscribers. Over the past few years, SiriusXM has
20 expanded its reach into Internet-based digital streaming transmissions.

21 15. SiriusXM was formed in 2008, as a result of the merger between Sirius Satellite
22 Radio and XM Satellite Radio. XM Satellite Radio initially launched in September 2001. Sirius
23 began service in July 2002. Since Sirius earned its first post-merger profit in the fourth quarter of
24 2009, it has grown rapidly, adding 5 million subscribers to its service. In the second quarter of
25 2013, the number of SiriusXM subscribers surged to over 25 million. In 2012, the company
26 earned \$3.4 billion in revenue, and in that year alone automakers installed over 10 million
27 SiriusXM satellite radios in new cars – roughly two out of every three new cars sold.

1 16. Prior to 2009, SiriusXM's broadcast activities were limited to satellite
2 transmissions. In June 2009, it began to offer an application ("App") that allowed users to listen
3 to over 120 of SiriusXM's channels via their Apple iPhones. In February 2010, SiriusXM
4 expanded the App for use on Blackberry devices, in May 2010, to Android smartphones, and in
5 March 2011, to Apple's iPad. In April 2013, Sirius launched "MySXM," an Internet radio service
6 that allows users to create custom music channels.

7 17. SiriusXM is a subscription-based service. It sells its service for \$14.49 per month
8 (for its "Select" package) and \$17.99 per month (for its "Premier" package). The "Select"
9 package provides over 165 satellite radio channels to its subscribers, including around-the-clock
10 "commercial-free music, sports, talk, and entertainment." Of the seven categories into which
11 SiriusXM characterizes its channels (for example, "Sports Talk/Play-by-Play," "News & Issues,"
12 and "Comedy"), by far the largest category is "Commercial-Free Music," which SiriusXM claims
13 has 72 channels. (By point of comparison, the second-largest category, "Talk & Entertainment,"
14 has only 22 channels.) SiriusXM's "Commercial-Free Music" channels range from classical (*e.g.*
15 "Met Opera Radio") to contemporary (*e.g.* "Alt Nation," "Hip-Hop Nation"), to everything in
16 between (*e.g.* "Underground Garage," "Prime Country," "enLighten," and "On Broadway").

17 18. SiriusXM recognizes the enormous value to its business of Pre-72 Recordings and
18 the popularity of Pre-72 Recordings among its paying subscribers. Therefore, SiriusXM regularly
19 advertises and promotes the availability of Pre-72 Recordings on its service. A significant portion
20 of SiriusXM's channels feature classic sound recordings, including channels exclusively devoted
21 to performing recordings from the '40s, '50s, '60s, and '70s. SiriusXM selects the most popular
22 and well-known recording artists and Pre-72 Recordings to perform on its service, including those
23 identified on Schedule A. On the "'60s on 6," channel, for example, SiriusXM lists as among the
24 "Artists You'll Hear" Plaintiffs' artists such as the Beatles, the Beach Boys, the Supremes, the
25 Four Tops, the Rolling Stones, Aretha Franklin, Petula Clark, Four Seasons, Simon & Garfunkel,
26 Tommy James, the Hollies, and Paul Revere. Other channels also are dedicated to or heavily
27 feature vintage Pre-72 Recordings including "Classic Vinyl" ("60s and 70s Classic Rock"), "Deep
28 Tracks" ("Deep Classic Rock"), "Soul Town" ("Classic Soul/Motown"), "B.B. King's Bluesville"

1 (“B.B. King’s Blues”), and “Willie’s Roadhouse” (“Classic Country Songs”). All of the foregoing
2 channels perform Plaintiffs’ Pre-72 Recordings as part of a continuous, uninterrupted public music
3 feed.

4 19. SiriusXM publicly performs thousands of Plaintiffs’ Pre-72 Recordings each day,
5 to millions of SiriusXM subscribers. Additionally, SiriusXM has reproduced thousands of
6 Plaintiffs’ Pre-72 Recordings. Plaintiffs are informed and believe, and on that basis allege, that
7 SiriusXM has done so, among other ways, by obtaining Plaintiffs’ recordings and copying them to
8 its servers and to its satellites, ultimately to be transmitted to subscribers. Plaintiffs are informed
9 and believe, and on that basis allege, that SiriusXM has publicly performed and reproduced
10 Plaintiffs’ Pre-72 Recordings millions of times throughout the United States, including in the State
11 of California and County of Los Angeles. The list of Pre-72 Recordings identified on Schedule A
12 is a sampling of Plaintiffs’ Pre-72 Recordings that SiriusXM publicly performed on its stations on
13 only a single day (August 1, 2013). These recordings represent just a small fraction of the total
14 number of the Pre-72 Recordings played by SiriusXM on an ongoing and regular basis.

15 20. Plaintiffs have never authorized SiriusXM to duplicate or publicly perform any of
16 their Pre-72 Recordings. Although a significant portion of SiriusXM’s \$3.4 billion in revenue is
17 attributable to Plaintiffs’ Pre-72 recordings, and though SiriusXM capitalizes on its customers’
18 desire to listen to these recordings, SiriusXM refuses to seek authorization from Plaintiffs or pay
19 any royalties or other compensation to Plaintiffs. This is in sharp contrast to SiriusXM’s
20 recognition that digital public performance royalties are required to be paid for the performance of
21 post-72 sound recordings protected by the federal Copyright Act.

22 21. By its conduct, SiriusXM not only deprives Plaintiffs of the revenues to which they
23 and others are entitled, but also undercuts those streaming services that do obtain licenses from,
24 account to, and pay Plaintiffs for the performance of Plaintiffs’ Pre-72 Recordings. Moreover,
25 SiriusXM’s refusal to pay for its widespread use of Pre-72 Recordings directly contravenes
26 California law and policy, which, as next described, always have provided equal, if not greater,
27 rights to owners of sound recordings than the federal Copyright Act.

1 California's Protections Of Pre-72 Recordings

2 22. Listening to musical sound recordings brings pleasure to tens of millions of people
3 of all ages and from all walks of life. Sound recordings are enjoyed in homes, in cars, in
4 restaurants and nightclubs, and at public gatherings. The revenue derived from the sale, licensing,
5 and other exploitation of sound recordings has provided employment for tens of thousands of
6 people in California and elsewhere, and the record industry has been a pillar of the California
7 economy for decades. In turn, for more than 40 years, California has provided uninterrupted
8 common law and statutory protection to the owners of Pre-72 Recordings against those who
9 exploit them without license or compensation.

10 23. The existence of a common law property right in Pre-72 Recordings first was
11 explicitly recognized by California courts in the seminal case of *Capitol Records, Inc. v. Erickson*,
12 2 Cal. App. 3d 526, 537 (1969). In 1982, California amended its Civil Code to provide, in
13 addition, statutory protection for Pre-72 Recordings: “[t]he author of an original work of
14 authorship consisting of a sound recording initially fixed prior to February 15, 1972, has an
15 exclusive ownership therein until February 15, 2047, as against all persons except one who
16 independently makes or duplicates another sound recording that does not directly or indirectly
17 recapture the actual sounds fixed in such prior sound recording; but consists entirely of an
18 independent fixation of other sounds, even though such sounds imitate or simulate the sounds
19 contained in the prior sound recording.” Civil Code § 980(a)(2).

20 24. In 1972, the United States Copyright Act was amended to add for the first time
21 “sound recordings” to the list of works protected under federal copyright law. 17 U.S.C. §
22 102(a)(7). At the same time, Congress also preserved “any rights or remedies under the common
23 law or statutes of any State” with respect to sound recordings “fixed” before February 15, 1972.
24 17 U.S.C. § 301(c). As a result, pre-existing California protection for Pre-72 Recordings was left
25 untouched and subject to evolution and refinement by the courts and the state legislature.
26 California’s commitment to protecting Pre-72 Recordings was reaffirmed by the subsequent
27 amendment to Civil Code § 980 in 1982. Unlike the inclusive scope of protection afforded to Pre-
28 72 Recordings by California state law, Congress initially limited the federal sound recording

1 copyright to include certain of the exclusive rights conferred on other works – namely, the rights
2 of reproduction, adaptation, and distribution – and to exclude the right to publicly perform sound
3 recordings. California law, by contrast, has never delimited, either explicitly or implicitly, the
4 scope of common law or statutory protection of Pre-72 Recordings, and did not exclude the right
5 of public performance from the rights of “exclusive ownership” in Pre-72 Recordings.

6 25. This broad protection afforded to Pre-72 Recordings is consistent with the
7 recognition by California courts and the California legislature of critical, important public policy
8 interests in providing strong state law protection for sound recordings. These interests include (as
9 explained by the court in the *Capitol Records* case) ensuring that record companies receive
10 compensation from their “substantial” expenditure of “effort, skill, and money in selecting
11 performing artists and obtaining the exclusive right to record their performances” (2 Cal. App. 3d
12 at 537); as well as ensuring that the owners of sound recordings possess powerful and appropriate
13 remedies against those who seek to unfairly appropriate and profit from such artistic
14 performances. California’s protections for sound recordings thus are complete and robust,
15 providing that authors possess exclusive ownership interests in those recordings that are not
16 limited in any way. These protections encompass virtually any conduct by which individuals or
17 entities seek to profit from the skill and labor of Plaintiffs and their recording artists by
18 appropriating and exploiting Pre-72 Recordings for their own benefit, including by unauthorized
19 and unlicensed reproduction and public performance.

20 26. The need for effective state law protection of sound recordings is especially great
21 today. Owners of sound recordings face constant threats from individuals and entities who seek to
22 exploit those recordings for their own benefit, without authorization from or compensation to
23 those who have created the recordings and have undertaken the massive investment required to
24 make them and provide them to the public. The rise of digital media has made this threat acute, as
25 virtually anyone with a computer and an Internet connection can copy and then distribute and
26 perform high-quality music instantaneously to millions. As digital technology has improved,
27 broadband Internet access has become more readily available, and the cost of digital services has
28 diminished, music consumption habits have changed. Music consumers increasingly obtain and

1 enjoy music via online or satellite “radio” or digital streaming services instead of purchasing CDs
2 or digital music files. Today’s digital streaming services take a variety of forms, ranging from
3 high-quality subscription radio channels, to “customized” or preference-based Internet radio
4 services, to digital on-demand services.

5 27. To address the anticipated shift in music consumption habits and the rise of digital
6 radio services and, therefore, the need to provide *federal* protection for the performance of
7 copyrighted sound recordings, Congress passed the Digital Performance Rights in Sound
8 Recordings Act (“DPRA”), granting owners of *post-72* copyrighted sound recordings the right to
9 “perform the copyrighted work publicly by means of a digital audio transmission.” 17 U.S.C.
10 § 106(6). In enacting this legislation, Congress explained the need for this performance right as
11 follows:

12 Trends within the music industry, as well as the telecommunications
13 and information services industries, suggest that digital transmission
14 of sound recordings is likely to become a very important outlet for
15 the performance of recorded music in the near future.... These new
16 digital transmission technologies may permit consumers to enjoy
17 performances of a broader range of higher-quality recordings than
18 has ever before been possible... However, in the absence of
19 appropriate copyright protection in the digital environment, the
20 creation of new sound recordings and musical works could be
21 discouraged, ultimately denying the public some of the potential
22 benefits of the new digital transmission technologies. Current
23 copyright law is inadequate to address all of the issues raised by
24 these new technologies dealing with the digital transmission of
25 sound recordings and musical works and, thus, to protect the
26 livelihoods of the recording artists, songwriters, record companies,
27 music publishers and others who depend upon revenues derived
28 from traditional record sales. H.R. Rep. No. 104-274 (1995).

1 28. California had provided common law and statutory protection for Pre-72
2 Recordings without any exclusions and including the right of public performance. However, the
3 issues Congress noted when it enacted the DPRA apply equally to Pre-72 Recordings. Pre-72
4 Recordings comprise a significant and important share of the overall body of existing musical
5 recordings, and include some of the most popular and valued recordings in history. Many digital
6 radio channels and services are dedicated entirely to the dissemination and performance of Pre-72
7 Recordings, such as classic rock, jazz, R&B, and classical recordings. The interests of fairness
8 and just compensation that underlie California's common law and Civil Code Section 980 compel
9 the conclusion that those, like SiriusXM, who build their business and make money from the
10 copying and public performance of Pre-72 Recordings must obtain the right to use them and
11 compensate their owners. Were it otherwise, federal copyright protection for sound recordings
12 would be more extensive than California's protection for Pre-72 Recordings. That has never been
13 the law, and is not the law now.

14
15 **FIRST CAUSE OF ACTION**

16 **(Violation Of California Civil Code Section 980(a)(2))**

17 29. Plaintiffs incorporate by reference each and every allegation contained in
18 paragraphs 1 through 28, inclusive.

19 30. Plaintiffs possess "exclusive ownership" interests in and to their Pre-72
20 Recordings, pursuant to California Civil Code Section 980(a)(2), which provides: "The author of
21 an original work of authorship consisting of a sound recording initially fixed prior to February 15,
22 1972, has an exclusive ownership therein until February 15, 2047...." Therefore, as owners of
23 their Pre-72 Recordings, Plaintiffs have all the exclusive rights to exploit those recordings,
24 including, but not limited to, the rights to manufacture, copy, sell, distribute, broadcast, and
25 publicly perform their Pre-72 Recordings, including by digital transmission.

26 31. Plaintiffs have not authorized Defendants to publicly perform, reproduce, or
27 otherwise exploit their Pre-72 Recordings via their satellite and digital Internet transmissions.

1 Defendants do not have the right to reproduce or publicly perform their Pre-72 Recordings and
2 have never compensated Plaintiffs for Defendants' exploitation of their Pre-72 Recordings.

3 32. Through their conduct alleged herein, Defendants have violated Plaintiffs'
4 exclusive rights to publicly perform and reproduce their Pre-72 Recordings, including those
5 identified on Schedule A.

6 33. Plaintiffs are harmed, and a new violation of Civil Code Section 980(a)(2) occurs,
7 giving rise to a new liability, each time Defendants reproduce or publicly perform one of
8 Plaintiffs' Pre-72 Recordings without the right to do so. As a direct and proximate result of
9 Defendants' conduct in violation of Plaintiffs' exclusive rights under Section 980(a)(2) in and to
10 their Pre-72 Recordings, Defendants have received proceeds and Plaintiffs have been damaged in
11 an amount to be proven at trial.

12 34. Defendants are guilty of oppression, fraud or malice, and Plaintiffs, in addition to
13 their actual damages, are, by reason thereof, entitled to recover exemplary and punitive damages
14 against Defendants.

15 35. Defendants' conduct is causing, and unless enjoined and restrained by this Court
16 will continue to cause, Plaintiffs great and irreparable injury that cannot fully be compensated or
17 measured in money. Plaintiffs have no adequate remedy at law. Plaintiffs are entitled to
18 preliminary and permanent injunctions prohibiting further violation of Plaintiffs' exclusive
19 ownership rights in their Pre-72 Recordings pursuant to Section 980(a)(2).

20
21 **SECOND CAUSE OF ACTION**

22 **(Common Law Misappropriation)**

24 paragraphs 1 through 28, inclusive.

25 37. Through their conduct alleged herein, Defendants have misappropriated Plaintiffs'
26 intangible rights, property, skill, and labor embodied in their Pre-72 Recordings, in violation of
27 Plaintiffs' rights in such recordings, including those identified in Schedule A, to Plaintiffs' harm
28 and detriment.

11 measured in money. Plaintiffs have no adequate remedy at law. Plaintiffs are entitled to

13 common law rights in their Pre-72 Recordings.

15 **THIRD CAUSE OF ACTION**

16 **(Statutory And Common Law Unfair Competition)**

17 41. Plaintiffs incorporate by reference each and every allegation contained in
18 paragraphs 1 through 28, inclusive.

19 42. The acts and conduct of Defendants alleged herein constitute an appropriation of
20 Plaintiffs' skill and labor and an invasion of the property rights of Plaintiffs in their Pre-72
21 Recordings from which Defendants profit, and constitute unfair competition under California
22 Business & Professions Code §17200 *et seq.* and under the common law.

23 43. Plaintiffs are harmed, and a new act of unfair competition occurs giving rise to a
24 new liability, each time that Defendants reproduce or publicly perform one of Plaintiffs' Pre-72
25 Recordings without the right to do so. As a direct and proximate result of Defendants' conduct,
26 Plaintiffs further are entitled to recover all proceeds and other compensation received or to be
27 received by Defendants attributable to the infringement of their Pre-72 Recordings.

1 44. As a direct and proximate result of Defendants' unfair competition, Plaintiffs have
2 been damaged, and Defendants have been unjustly enriched, in an amount to be proven at trial for
3 which damages and/or restitution and disgorgement is appropriate. Such damages and/or
4 restitution and disgorgement should include a declaration by this Court that Defendants are
5 constructive trustees for the benefit of Plaintiffs, and an order that Defendants convey to Plaintiffs
6 the gross receipts received or to be received by them that are attributable to infringement of their
7 Pre-72 Recordings.

8 45. Defendants' conduct is causing, and unless enjoined and restrained by this Court
9 will continue to cause, Plaintiffs great and irreparable injury that cannot fully be compensated or
10 measured in money. Plaintiffs have no adequate remedy at law. Pursuant to California Business
11 & Professions Code § 17203, Plaintiffs are entitled to preliminary and permanent injunctions
12 prohibiting further acts of unfair competition.

13
14 **FOURTH CAUSE OF ACTION**

15 **(Conversion)**

16 46. Plaintiffs incorporate by reference each and every allegation contained in
17 paragraphs 1 through 28, inclusive.

18 47. Plaintiffs are, and at relevant times were, the exclusive owners of all right, title, and
19 interest in and to their Pre-72 Recordings. Plaintiffs' rights in their Pre-72 Recordings constitute
20 intangible property.

21 48. By the acts and conduct alleged herein, Defendants have exercised dominion or
22 control over Plaintiffs' Pre-72 Recordings and have applied Plaintiffs' property to their own use
23 and benefit, without license or consent, and converted Plaintiffs' property rights in their Pre-72
24 Recordings, including those identified on Schedule A.

25 49. Plaintiffs are harmed, and a new act of conversion occurs giving rise to a new
26 liability, each time that Defendants reproduce or publicly perform one of Plaintiffs' Pre-72
27 Recordings without the right to do so. As a direct and proximate result of Defendants' acts of
28 conversion, Plaintiffs have been damaged, and Defendants have been unjustly enriched, in an

1 amount to be proven at trial for which damages and/or restitution and disgorgement of
2 Defendants' gross receipts is appropriate.

3 50. Defendants are guilty of oppression, fraud or malice, and Plaintiffs, in addition to
4 their actual damages, by reason thereof, are entitled to recover exemplary and punitive damages
5 against Defendants.

6 51. Defendants' conduct is causing, and unless enjoined and restrained by this Court
7 will continue to cause, Plaintiffs great and irreparable injury that cannot fully be compensated or
8 measured in money. Plaintiffs have no adequate remedy at law. Plaintiffs are entitled to
9 preliminary and permanent injunctions prohibiting further acts of conversion.

10
11 **FIFTH CAUSE OF ACTION**

12 **(Declaratory Relief)**

13 52. Plaintiffs incorporate by reference each and every allegation contained in
14 paragraphs 1 through 28, inclusive.

15 53. An actual dispute has arisen and now exists between Plaintiffs, on the one part, and
16 Defendants, on the other part.

17 54. Plaintiffs contend that Defendants' ongoing and future copying, public
18 performance, and exploitation of Plaintiffs' Pre-72 Recordings, without Plaintiffs' authorization or
19 consent, and without compensation to Plaintiffs, violates Plaintiffs' exclusive reproduction and
20 public performance rights in their Pre-72 Recordings under California Civil Code Section
21 980(a)(2) and the common law. Defendants dispute Plaintiffs' contention and contend otherwise.

22 55. Plaintiffs request a judicial declaration of the rights and duties of the parties with
23 respect to Plaintiffs' property, specifically that Defendants' unauthorized, ongoing and future
24 reproduction and public performances of Plaintiffs' Pre-72 Recordings, without authorization,
25 consent or payment, violate Plaintiffs' exclusive rights under California Civil Code Section
26 980(a)(2) and the common law.

27 56. Such a declaration is necessary and proper at this time under all the circumstances
28 in order to resolve present and continuing disputes between the parties, to prevent further violation

1 of Plaintiffs' exclusive rights in their Pre-72 Recordings, and to avoid a multiplicity of future
2 actions.

3
4 WHEREFORE, Plaintiffs pray for a judgment and declaration against Defendants, and
5 each of them, jointly and severally, as follows:

6 1. Preliminary and permanent injunctions enjoining and restraining Defendants, and
7 each of them, and their respective agents, servants, directors, officers, principals, employees,
8 representatives, subsidiaries and affiliated companies, successors, assigns, and those acting in
9 concert with them or at their direction, from directly or indirectly infringing in any manner any
10 right in any and all Pre-72 Recordings in which any Plaintiff owns or controls an exclusive right
11 under statutory or common law, including without limitation by directly or indirectly reproducing
12 and publicly performing any of Plaintiffs' Pre-72 Recordings, including but not limited to those
13 identified on Schedule A.

14 2. Imposition of a constructive trust.

15 3. Restitution of Defendants' unlawful proceeds, including Defendants' gross receipts
16 attributable to their unauthorized use of Plaintiffs' Pre-72 Recordings.

17 4. Damages according to proof.

18 5. Punitive damages in such amount as may be awarded at trial.

19 6. A declaration that Defendants' unauthorized, ongoing, and future reproduction and
20 public performances of Plaintiffs' Pre-72 Recordings without authorization, consent or payment,
21 violate Plaintiffs' exclusive rights under California Civil Code Section 980(a)(2) and the common
22 law.
